PAC Contribution Disclosure

During the past two years, there were zero instances where there was substantial misalignment between JPMC PAC political contributions and the policies and initiatives of importance to the Firm, as outlined in JPMorgan Chase & Co.'s Political Engagement and Public Policy (PEPP) Statement.

Lobbying

On the state and local level, our Government Relations and Public Policy team (GRPP) lobbies primarily in states in which the Firm has a retail presence or other material business operations. Current information is available about our [retail locations](#).

At the federal level, the Firm makes quarterly filings with the U.S. Congress disclosing GRPP's federal lobbying expenditures and the issues on which they have lobbied. For the past three calendar years, we have reported lobbying expenditures of \$4.38 million in 2025, \$3.6 million in 2024, and \$3.31 million in 2023. Key subjects on which GRPP lobbies include Banking, Financial Services, Cybersecurity, Small Business, Tax Policy, Consumer issues, and Travel and Tourism.
